“Inasmuch as every government is an artificial person, an abstraction, and a creature of the mind only, a government can interface only with other artificial persons. The imaginary having neither actuality nor substance, is foreclosed from creating and attaining parity with the tangible. The legal manifestation of this is that no government, as well as any law, agency, aspect, court, etc. can concern itself with anything other than corporate, artificial persons and the contracts between them.” S.C.R 1795, (3 U.S.54; 1 L.Ed. 57; 3Dall. 54.)

Box 3. - DEPARTMENT OF THE TREASURY – *de facto*, Inc. D&B No. 026661067, Secured Party Creditor ordered in box 12, to be “compensated” 2.5 Million in gold coin to (Box 3c) remittance⁴ room 3413.

Box 4. - Collateral: the key to understanding the code herein is: all upper-case words mean fake, not real, *de facto*, finite, Inc.; while lower case is real, *de jure*, infinite; but a mixture of both cases in a word is a mixture of real and fiction).

The last sentence:

“Discharge [see discharge in the fine print in box 12] this tax matter.” So, Trump’s NY Case is (in lower case) really just a tax matter. *De facto* NEW YORK Inc.’s CLAIM as CLAIMANTS Inc. are charging a tax to Benefactor Trump’s Trust/estate [mixture] has a debt obligation now assigned to **Office** of the **Secretary** of the **Treasury** [mixture].⁵

The first sentence:

“...NOTICE OF SPECIAL DEPOSIT [not general⁶ deposit] FOR THE BENEFIT OF THE DEPOSITOR/SECURED PARTY [OFFICE OF THE TREASURY, Box 3] /GRANTEE BENEFICIARY [Inc.] CLAIMANT [Inc.]...”

Two Notices:

Notice No. 1) “ACTUAL AND CONSTRUCTIVE NOTICE...” by Inc. fiction; and No. 2) “Notice of claim of [on] all investment, commodity and trust deposit accounts [Inc. invested in the real-world securities stock mark] with attached collateral and proceeds [from Inc’s securities investments] to secure collateral along with [Inc.’s] claim of TRADEMARK/TRADENAME, COPYRIGHT/ PATENT of the Name [mix] DONALD JOHN TRUMP [Inc.’s Cannon Law Trust]. Finally, the dead Inc. TRUMP Trust speaks thru TRUSTEE Tingling:

“...my mind, body, souls of infants... reject[s] and rebuke[s] all assumptions and presumptions of being property of any Cestui Que Vie Trust/estates under CANON 2055...” An obvious ploy to get one to think the natural man POTUS Trump is making a statement of truth.

Box 12 - The money in Trump’s U.S. Treasury trust is already in the 1830, military "Deep State" coup d'etat illegitimately created treasury Inc. Is the treasury going to pay itself here? Are the money laundering trust prophets from securities being laundered here to escape income tax?

where it came from; to another pocket/department “REMITANCE ROOM 3413” (BOX 3c) as a “special deposit.” Also note the A4V

Why does it not go into the COUNTY or STATE’s “SURROGATE” COURT? Because the USA Incorporation is on big happy Roman Catholic Cannon Law (RCCL) mafia type FAMILY under a Doctrine of Discovery (DOD).

Summary

For the privilege of defending one’ self in a incorporated, surrogate court Inc. there is a tax/fee, as said court and all its employees and their “bonds” are working and racking up a debt to pass on to the unsuspecting, unaware natural man, a sovereign. sociopath, criminal, pedophile, etc. in the world; and 2) As the following two witnesses were in a federal prison for IRS tax debts when this was filed, they swear the hidden for years and just discovered UCC filings are forgeries.
